Madeleine Sophie Barat Foundress of the Society of the Sacred Heart

An early 19th Century Frenchwoman, Madeleine Sophie Barat championed the need for the education of women. This truly remarkable woman was born in the province of Burgundy and grew up surrounded by affection and security. She was not yet seventeen when 1794 ushered in the Reign of Terror. Though not imprisoned herself, she suffered with her compatriots who were in hiding or facing the guillotine. It was her deep faith and rich spiritual life that carried her through those days.

Today, the Society of the Sacred Heart educates women in some 35 countries. Her followers remain faithful to her inspiration. Like her, they remain open to new situations, making her vision their own – that people become ever more aware of truth, of love, of freedom and of responsibility. Besides their involvement in traditional forms of education at all levels, many are involved in adult education and other activities for human development including the promotion of justice.

Madeleine Sophie Barat died in 1865 and in 1925 was canonized by Pope Pius X1.

Statement to Abbot Maurus regarding Fr. Placidus' sexual conduct.

I was Rector of both the Major and Minor Seminary during the incidents referred to in Fr. Placidus' trial. Near the end of the 1983-84 school year when I was speaking to one of the seminarians about his vocation plans I learned he had had homosexual contact with one of the priests. The young man-he was 19--did not tell me who the priest was. When I reported the incident to the Father Placidus, the Vice-Rector, he answered at once that the person in guestion was himself. Both men made these disclosures to me within a few days of the event.

I spoke to Father Placidus again in more detail today. He told me that it was the only genital homosexual contact he has ever had. He said it was a case of masturbation in his office. I think he would be prepared to swear that it was the only instance of genital touching on his part. His truthfulness in admitting the event first during the police investigation and then at the trial is impressive in view of the consequences he must have foreseen. In his verdict the judge said he believed Father Placidus but not the complainants. And from my perception of his initial admission to me, I would say that if he were a pedophile he would not have admitted his involvement when I did nothing more than report to him what the student had told me. That spontaneous and contrite acknowledgment made a deep impression on me,

In the report I sent, November 4, 1995, to Constable Clary I included these memories of Father Placidus' reaction: "He was broken up over the incident, mentioned to me the name of the priest to whom he had related the incident--which I presumed was in the sacrament of confession--and he told me he would do whatever I thought he should do. He also mentioned what a blow this would be to Father Abbot Eugene if he knew. I did not say anything to anybody. I was sure Father Placidus was genuinely sorry. I did not consider him as an aggressor but that his sympathetic disposition get him into the mess." Constable Clary told me the young man did not wish to place charges on Father Placidus.

To my mind truthfulness is one of Father's special virtues. In the 50 years I have known him--and during many of them I worked closely with him--I have never known him to tell the slightest lie; if anything, he is tediously and scrupulously exact in recounting what he knows.

He is a key member of our community, the backbone of our choir, a good teacher with heavy classes, a favorite with guests especially for those looking for a sympathetic ear. I think that both he and our community have already suffered very much from the false charges in the media and the papers have done little to publicize the verdict. Our community and the students must have been impressed by the calm and patience in which Father Placidus has taken the heat.

The From Pain to Hope program is appropriate for a genuine Pedophile or a pervert. The allegations and trial have taught Father more effectively than counselling would. If in addition we shelved him by disciplinary action that would tell our friends and the public that we consider Father's problem something more deep-seated than the single serious instance of weakness in an affectionate and sympathetic priest, then there would be an element of untruth in our own reaction.

Everybody on reflection is aware of human weakness and Catholics are routinely reminded of St. Peter's weakness. If his problem is thought to be more serious than just weakness, then a more professional assessment should first be made.

The abbey said Father Placidus "deeply regrets the scandal caused by the isolated incidents of improper behavior" admitted by him during the course of the trial.



Pope declares Padre Pio venerable, advances others

The cause for the beatification of Padre Pio, a popular but contro-



versial Italian Capuchin confessor was one of 15 that took a step for ward Dec. 18 with the promulga tion of papal decrees.

Among the decrees was also recognition of the heroic virtues c Sister Delia Tetrault, the Canadia founder of the Missionary Sister of the Immaculate Conception.

Padre Pio, who was born i 1887 and died in 1968, had bee investigated several times durin his lifetime by the Vatican for al leged immorality and financial in regularity, but hundreds of peopl continued flocking to him, askin for his prayers and confessin their sins.

Padre Pio allegedly had super natural powers and bore the stig mata, the marks of Christ' crucifixion

The proclamation that he lived holy life worthy of imitatio means that the only remaining hu dle to his beatification is the Vat can recognition of a miracl attributed to his intercession.

The other decrees publishe Dec. 18 included the recognition (miracles attributed to the interce sion of two Italian and two Spanis nuns, as well as to an Italian lay man, Giuseppe Antonio Tovin who died in 1897.

The Pope also proclaimed theroic virtues of Carmelite Sist Teresa of St. Augustine, the daugl ter of King Louis XV of France; ar of Cesare Pisano, a blind Italia hermit known as Brother Av Maria, who died in 1964.

By LAUREEN McMAHON Archbishop Adam Exner OMI says he is pleased that the Saskatchewan Justice Department plans to appeal the twovear sentence handed to Robert Latimer for killing his disabled daughter, Tracy.

'This news will be reassuring to disabled people, whose lives must never be seen as worth less than those of others," said the archbishop.

"The lesson of history is clear. Whenever the lives of some are seen as worth less than the lives of others, the consequences are always horrendously inhuman and tragic."

Disabled rights and antieuthanasia groups also said Saskatchewan had made the right decision. "We strongly support the decision to appeal," said Yoseph Thomson of the Euthanasia Prevention Coalition. "We believe the trial judge was wrong. While Mr. Latimer got compassion, Tracy got a death sentence."

Other advocates for the disabled had a similar message. "I'm really pleased that they are doing this because I know we've put a lot of pressure on them," said Bev Boehm of Saskatchewan Voice of People with Disabilities. "We thought that there was an injustice done-that people with disabilities are fearful for their lives and this was just opening a whole can of worms."

Justice Ted Noble of the Saskatchewan Court of Queen's Bench granted Latimer a constitutional exemption from the minimum second-degree murder penalty Dec. 1, outraging disabled people's groups across the country.

It was the first ruling of its kind in a murder case.

Noble ruled that Latimer had killed the 12-year-old out of mercy and that it would be cruel and unusual punishment to sentence him to mandatory life in prison with no chance of parole for 10 years.

The 43-year-old Latimer was sentenced to two years less a day, with half the sentence to be served in a provincial jail and half on his farm in Wilkie, Saskatchewan.

Although he was convicted of second-degree murder in November 1994, an appeal was launched on the grounds that his confession to the police had been improperly obtained. The Supreme Court unanimously rejected his claim but ordered a new trial because of allegations of jury-tampering.

He was found guilty for the second time in Battleford, Saskatchewan, November 5.

Latimer's defense lawyer Mark Brayford says he is disappointed with news of the appeal and that he plans to confer with his client about a counter-appeal.

In a written statement, Brayford said he considered Mr. Justice Noble's original decision on sentencing "a fair compromise that society could live with.'

Latimer, who is currently in a Saskatoon jail, had no comment. Earlier this month, Professor

Alan Young of Osgoode Hall law school had said Latimer's chances in an appeal were good because it is "based on compelling compassionate circumstances.

"The only thing that cuts against its success is the general aversion courts have to creating constitutional exceptions, because what it does is carve up an existing constitutional law," said Professor Young.

By LYNNE WEIL VATICAN CITY (CNS)—International debt and official corruption are major obstacles to world peace, Pope John Paul II said in an annual message.

The Pontiff's thoughts for the World Day of Peace, observed each year for the last three decades on Jan. 1, were published Dec. 16 at the Vatican

Pope John Paul said he wanted to address his remarks to heads of state this year, adding, "May the codes which govern the states you serve be a guarantee of justice for the people and an incentive for an ever growing sense of civic responsibility.'

The Pope emphasized throughout the document that jus-

tice and peace are inextricably linked. The head of the Pontifical Council for Justice and Peace, Cardinal Roger Etchegaray, said at a news conference that "the face of the poor can be found in every paragraph" of the message.

Cardinal Etchegaray called the document "a message of vast horizons which confronts today's primary challenges.'

The 16-page message discussed several economic issues, including debt burdens faced by developing countries, corruption of government and legal authorities, the gulf between the wealthy and the poor, and access to credit.

The Pope praised programs which offer "minicredit," or small and short-term loans for projects by people who would otherwise have trouble getting bank loans.



Further to my letter to you of December 2, 1998, I have now had an opportunity of reviewing the transcript of your evidence given at your criminal trial respecting charges of indecent assault, gross indecency and buggery. In order to complete my investigation preparatory to this matter being referred to the Independent School teacher Certification Committee, I request an interview with you in order to obtain further information regarding certain conduct and actions disclosed in the proceedings.

Apart from information regarding the substance of the criminal charges, I am also concerned by two further disclosures made in the proceedings. The first disclosure relates to your admission of kissing a student on the lips and acknowledging that this was inappropriate conduct. The second matter relates to your admission of a consensual homosexual genital act between yourself and a grade 12 student at the Seminay of Christ the King at Westminster Abbey in Mission. I am sure you will appreciate that these matters are fundamental to the issue of your fitness to retain your Independent School teacher certification. Consequently, I will be contacting you in the next few weeks to arrange a suitable time and place for the interview.

There is a further inquiry that I would make of you at this time as it may affect the course of my investigation. It is my understanding that you have been engaged in other duties in the Seminary and have not been involved in teaching students of school age for some considerable time. If, in fact, you do not propose returning to teaching school age students, you may have no further need to maintain an active Independent School Teacher Certificate. Clearly, these are matters for you to determine. However, if you were contemplating voluntarily relinquishing your Independent School teacher certification at this time, perhaps you would advise me accordingly as that would obviate the need for further investigation of these matters.

- 4) Once the agreement between the Archdiocese and the Seminary has been agreed upon the canonical statutes of the Seminary of Christ the King should be developed and submitted to the Holy See. The rule of life should also be updated in the future.
- 5) It was discussed by the committee that the seminarians would benefit from increased communication among seminary formators. Perhaps faculty could meet regularly (or at least once) before the faculty evaluations in the spring to discuss each of the seminarians and their particular formation needs. This increased communication could help formators work as a team by being on the same page as well as airing any disagreements that may exist among formators. The Archdiocese requests that the observations of Jake Khym be incorporated into these discussions.

Agreement

Between the Archdiocese of Vancouver and Westminster Abbey

Regarding the Major Seminary of Christ the King

On the Feast of Christ the King, October 25, 1931, the Seminary of Christ the King was established and dedicated as the Major and Minor Seminary of the Archdiocese of Vancouver.

Later, at the invitation of the Archbishop of Vancouver, on July 22, 1939, the Benedictines established a foundation in the Archdiocese to take charge of the Seminary of Christ the King. The land and buildings that currently constitute both Seminaries, Major and Minor, belong to Westminster Abbey and are maintained by the Abbey and not by the Archdiocese (cf. CIC, c. 263).

In the light of this relationship, the Archdiocese and Westminster Abbey recognize that this Agreement refers only to the governance of the Major Seminary. The Minor Seminary will remain, for the present, under the full responsibility of Westminster Abbey.

- The Major Seminary of Christ the King's program for priestly formation is recognized as the Major Seminary of the Archdiocese of Vancouver (cf. CIC, cc. 237, 681; The Constitution and Statutes of the Swiss-American Benedictine Congregation, C58.2 and S59.1.)
- The Seminary of Christ the King is a Major Seminary which receives only men who intend to pursue studies leading to ordination to the priesthood.
- 3. This Agreement will be in force for a period of ten years, after which time it may be renewed for a further period agreed to by both parties.
- 4. Neither party will rescind the Agreement without at least three years' notice; nor will they make any changes in it unless agreed upon by both parties and with a year's prior notice.
- 5. The Abbot of Westminster Abbey appoints the Rector, Vice-Rector, Spiritual Director, and faculty members subject to confirmation by the Archbishop of Vancouver. All teachers of the sacred sciences must receive the *mandatum* from the Archbishop of Vancouver (cf. CIC, c. 253).

- 6. To foster communion between the two parties and to assist in the formation of seminarians as diocesan clergy, the formation faculty of the Seminary should include diocesan priests who, if both the Abbot of Westminster Abbey and the Archbishop of Vancouver agree, will participate fully at meetings at which seminarians are evaluated.
- 7. The Archbishop of Vancouver is to receive, at least yearly, a report regarding the progress in all aspects of formation of every seminarian studying for the Archdiocese.
- 8. The Archbishop of Vancouver has the right of visiting the Seminary as often as he wishes and likewise can correct those things which, according to general or particular law and the norms established by the Congregation for the Clergy, might harm the proper formation of seminarians in piety, learning and discipline (cf. CIC, cc. 259 §2, 397).
- The Archbishop of Vancouver reserves the right to approve the program of studies for the Major Seminary. He is to ensure its conformity with the current *Ratio Fundamentalis* of the Holy See and with that promulgated by the Canadian Conference of Catholic Bishops (cf. CIC, c. 243).
- 10. The Seminary will have its own Rule, approved by both the Archbishop of Vancouver and the Abbot of Westminster Abbey (cf. CIC, c. 243).
- The law or norms according to which the governance of the Seminary is to be regulated will be clearly indicated. Statutes are to be approved by the Archbishop of Vancouver and the Abbot of Westminster Abbey (cf. CIC, c. 239 §3). These Statutes will also be in agreement with the civil Charter and Bylaws.
- 12. Although Westminster Abbey is responsible for the financial support of the Seminary, the Archdiocese of Vancouver may enter into a separate agreement with the Abbey whereby it pays for the whole or part of the remuneration of particular professors or formators at the Seminary. The Archdiocese of Vancouver recognizes its obligation to support the Seminary financially when and if Westminster Abbey presents a request for funding.
- 13. If the need arises, the Seminary, with the consent of the Archbishop of Vancouver, may raise funds for itself in the Archdiocese (cf. CIC, c. 264). Any funds collected will be the property of the Seminary of Christ the King.
- 14. The Archbishop of Vancouver agrees to send his seminarians (arts, pretheology and theology) to the Seminary of Christ the King, except in particular cases in which, according to his prudential judgment, a seminarian's formation or the needs of the Archdiocese would be better served in another seminary.

- 15. The student fees will be set by Westminster Abbey, according to prevailing economic conditions.
- 16. The provisions of this Agreement are to remain firm, notwithstanding any privileges conceded to the Order of St Benedict.
- 17. This Agreement replaces the contract made between the Archdiocese of Vancouver and Westminster Priory entered into on August 25, 1949, and formally ratified by the Sacred Congregation of Seminaries and Universities on September 21, 1949.

Given at Vancouver, British Columbia, Canada, on this 29th day of June, the Solemnity of Saints Peter and Paul, Apostles, in the Year of Our Lord, Two Thousand and Seventeen.

Addendum to the Agreement

Should the apostolic work of the Seminary of Christ the King be changed or altered in a significant manner through suppression, transfer, the erection of another Archdiocesan Seminary, or the sending of students to another Seminary, the Archdiocese of Vancouver recognizes and accepts the following:

- 1. Westminster Abbey's responsibility of discerning a suitable apostolic work to sustain the monastic community which is mutually agreed upon by Westminster Abbey and the Archdiocese of Vancouver, unless the monastic community decides not to pursue an apostolic work in the Archdiocese of Vancouver.
- 2. The responsibility of providing necessary monies to Westminster Abbey to accommodate changes to buildings and grounds brought about concerning the above. This would apply primarily to the Major Seminary, which is the object of this Agreement.
- 3. The Archbishop's acknowledgement for Westminster Abbey to continue to provide education for students pursuing priestly studies and forming members of other religious institutes.
- 4. The name of the Seminary shall be retained, namely, "Seminary of Christ the King."

Monk wins acquittal on sex charges

CHILLIWACK — A Westminster Abbey monk has been acquitted of all six sex-offence charges against him.

B.C. Supreme Court Justice Richard Blair said the evidence given by the three complainants was unreliable and could not prove beyond a reasonable doubt the offences were committed.

Harold Vincent Sanders, 70, was on trial on charges of buggery, gross indecency and four counts of indecent assault for allegedly sexually assaulting three teenage boys at the Mission monastery.

"There were so many inconsistencies and contradictions given in the evidence," said Blair. "I cannot convict the accused of any of the charges. I find the Crown's case not to be beyond a reasonable doubt."

The three complainants, who cannot be named because of a publication ban, testified they were sexually assaulted by Sanders, also known as Father Placidus, between 1974 and 1978.

Sanders refused to comment after his acquittal. Fellow Westminster Abbey monk Father Maurus Macrae said they were pleased with the decision.

One complainant said he is upset that Sanders will be returning to the monastery, particularly since during the trial Sanders admitted to having consensual sex with an 18-year-old student.

"I find this is so bizarre, that he admitted to having sex with a high-school student at the seminary and now he's going back there to teach," he said.

Evidence unreliable, monk's lawyer argues

CHILLIWACK — A monk facing sex-offence charges should be acquitted because of unreliable evidence and inconsistent memories recounted by the three complainants, says lawyer Richard Peck.

"The Crown's case is so full of inconsistency and some points of exaggeration, the standards of proof point to reasonable doubt," Peck told B.C. Supreme Court yesterday.

Peck is defending Harold Vincent Sanders, a monk at Mission's Westminster Abbey, against charges of buggery, gross indecency and indecent assault involving three teenage boys in the 1970s.

One complainant testified he remembers drawing a profile of his art teacher, Sanders, known as Father Placidus, during class. He said the monk told him to come to his office afterward for what the then-13-year-old thought would be a whipping. But when he went to the office, he said, the monk forced him to submit to anal intercourse.

Peck, however, said Father Placidus never taught art class.

"The details (the complainant) describes are sketchy," he said during final arguments. "It appears his evidence was totally unreliable."

Peck said the testimony of another complainant who claimed he was fondled by the monk may have been financially motivated. He said the complainant phoned the abbey in the late 1980s and asked for compensation for a broken arm he suffered at the monastery almost a decade earlier.

"His business went bankrupt, so he called the monastery asking for money," said Peck.

He said the third complainant has an extensive record of "dishonest" crimes.

But Crown counsel Jack Gibson said Father Placidus, as dormitory supervisor at the abbey, had the opportunity to assault the boys as alleged.

Justice Richard Blair is to hand down his decision Friday.

Assaults on boys denied by monk

CHILLIWACK — A monk on trial for allegedly sexually assaulting three teenage boys testified he would never commit such "serious offences" in the eyes of God.

"What is alleged is a serious offence against a person and a serious offence against God," Harold Vincent Sanders told the B.C. Supreme Court. "Categorically, they did not happen."

The Westminster Abbey monk, known as Father Placidus, was charged in 1996 with buggery, gross indecency and indecent assault after three complainants alleged they were assaulted by him while living in the monastery as students in the 1970s.

One testified that Father Placidus fondled his genitals while giving him a sponge bath. The 13-year-old boy was unable to wash himself because his arm was broken.

He said Sanders, on another occasion, came to his bed in the middle of the night and fondled him.

Sanders has admitted he gave the complainant a sponge bath but said he did not wash his genitals.

"I did not wash his genitals because he had one arm he could use for that purpose," he said. "I am definite about the fact that I did not do that."

Crown counsel asked Sanders whether he had perhaps blocked out the memory.

"I could not have blocked it out. I say this before the court and before God. I don't see how any human being could block that out. The conscience of someone would have to be hardened."

A second complainant testified last week that he was called to Father Placidus's office for what he believed was a strapping but instead was raped.

Sanders was the dormitory supervisor in the 1970s.

Chilliwack: Ex-Abbey Student Says Monk Fondled Him

Another former Westminster Abbey student testified he was fondled by Father Placidus on two occasions in 1977 as the monk's B.C. Supreme Court trial continued this week in Chilliwack.

The 33-year-old man said he had just turned 13 when Harold Vincent Sanders, known as Father Placidus, came to his bed in the middle of the night and fondled him. Sanders, 70, is on trial for buggery, gross indecency and four counts of indecent assault for incidents involving three seminary students in the 1970s.

Defence lawyer Richard Peck pointed out the complainant originally said he did not experience sexual abuse at the monastery and, in a statement to the Mission RCMP in 1993, said his year at the monastery was the best year of his life.

Monk admits consensual sex

CHILLIWACK — A Westminster Abbey monk on trial on sexual- assault charges says he had consensual homosexual relations with an older student.

Harold Vincent Sanders, known as Father Placidus, told B.C. Supreme Court yesterday he had consensual sex with an 18-year-old seminary student on one occasion in the 1980s. He said he often gave students hugs and kissed one student on the lips twice.

But the 70-year-old monk insisted he never touched boys without their consent: "I respect people. That is such an important thing in my beliefs."

He is charged with buggery, gross indecency and indecent assault relating to a series of alleged incidents in the 1970s.

Three complainants testified Sanders sexually assaulted them when they were teens living at the monastery and he was responsible for monitoring the junior boys' dormitory.

He remains a teacher at the Mission abbey.

Alleged rape ended dream of priesthood

CHILLIWACK — A child's dream of becoming a priest was shattered when he was raped by a monk at Mission's Westminster Abbey monastery, a man told B.C. Supreme Court yesterday.

The complainant, 34, said monk Harold Vincent Sanders, now 70, sodomized him when he was a 13year-old living at the monastery.

"I no longer believe in God," the alleged victim told the court. "After that incident, I didn't want to become a priest any more. I was thinking differently. I had an experience I didn't quite know how to deal with, and my belief in that institution had been destroyed."

Sanders, known as Father Placidus at the monastery, is charged with buggery, gross indecency and four counts of indecent assault for alleged attacks on three boys in the 1970s.

"I attended the school in 1977 because I wanted to become a priest. Father Placidus taught Latin and art classes and was the dormitory supervisor," he said.

During an art class, students were asked to sketch a profile of Father Placidus, he said. When the drawings were turned in, the monk asked the complainant to see him in his office.

The complainant said he thought he was going to get a whipping for doing something wrong. Instead, he said, Father Placidus sodomized him.

Monk molested me: Ex-student

CHILLIWACK — A monk charged with sexually assaulting three boys at Westminster Abbey in Mission pleaded not guilty in B.C. Supreme Court yesterday.

Harold Vincent Sanders, 69, was charged in January 1996 with buggery, gross indecency and four counts of indecent assault.

A three-year police investigation examined complaints by three men stemming from alleged incidents in the mid-1970s.

The first of the complainants testified he was assaulted by "Father Placidus" on at least three occasions while he lived at Christ the King Seminary, part of the abbey.

The 36-year-old complainant, who because of a publication ban cannot be named, said the first assault took place when he was in Grade 8 after his arm was "intentionally broken" by another monk.

"I had a cast that went around my whole arm and I couldn't move it whatsoever," he said. "I had to be bathed in the infirmary by the monks.

"I'm in the infirmary. I remember the door being shut. I didn't have anything on at all. I remember I was being sponge-bathed. (Sanders) seemed to be fixating on cleaning my penis and genital area a little more than necessary. I remember him playing with me.... The same thing happened the second time — he fondled and masturbated me."

The witness testified: "When I was in Grade 9, I woke up and found him on the side of my bed. He had his hand down by my genital area and was stroking me."

When asked by Crown counsel Jack Gibson whether he ever consented to these actions, the man replied, "Not a chance."

Defence lawyer Richard Peck asked the witness why he didn't mention the alleged sexual assaults in complaints filed with Delta police and Mission RCMP in 1993.

The complainant said he tried to tell the police about the assault on both occasions.

Sanders, who still lives at the abbey, refused a jury. He was released on \$2,500 bond. A second complainant is expected to testify today.

TEACHER AT ABBEY SEMINARY

- Harold (Father Placidus) Sanders served as a Benedictine monk at Westminster Abbey and taught at the Seminary of Christ the King.

- About 55 students at the seminary, ranging in age from 13 to the mid-50s, take high-school, college and theology classes. There are about 15 teachers, some of whom are monks.

- The monastery is self-sufficient in food. The monks grow vegetables and maintain a large herd of cattle.

Accused priest in court

A priest charged with sexually assaulting students at a seminary school at Westminster Abbey in Mission during the 1970s made a first appearance in court Wednesday.

Father Placidus, 68, also known as Harold Vincent Sanders, is charged with four counts of indecent assault, one count of gross indecency and one count of buggery.

At the time of the alleged abuse, the accused was a teaching father at the seminary school. He was released on bail and ordered not to be alone with persons aged under 16. His next court appearance will be March 1.

Priest facing 6 sex charges: Counts allege seminary teacher assaulted boys

A 68-year-old Mission priest turned himself in yesterday to face multiple sex charges from 20 years ago.

Father Placidus Sanders of Westminster Abbey in Mission, also known as Harold Vincent Sanders, was released on his own recognizance and a \$2,500 surety yesterday at Abbotsford provincial court.

Sanders is charged with a total of four counts of indecent assault, one count of gross indecency and one count of buggery against three male victims.

The acts are alleged to have taken place between 1974 and 1978, when the men were seminary students aged 12 to 14 years old.

Crown prosecutor Gregg Goodfellow told The Province that Sanders was a teaching father at the seminary at the time of the alleged acts.

The Mission RCMP investigation started in May 1993, when the initial complaints were made.

There are two publication bans preventing any further details becoming public.

Sanders' next court appearance is in Abbotsford March 1.

An alleged victim told The Province in an interview that his life became a nightmare after a four-year stint at Westminster Abbey.

He said during his stay at the abbey he fell off the roof and severely damaged both his legs.

"I've hardly ever been able to hold a job," he said yesterday. "Every time I do, my body gives out. I'm a basket case."

Coming forward, he said, will help to restore his self- confidence.

Hello Mrs. Ruggie-Andrews

My apologies if my subject line sounds a bit attacking, however I find it difficult to stomach yet another attempt by the church and namely the Archdiocese of Vancouver to sound as though it cares for those who have been sexually abused by those working within the church.

Back in 1993 I reported abuse that had happened to me at the Seminary of Christ the King in Mission in 1982. At the time of reporting, it was when all of the TV shows had come out reporting and recreating those acts of abuse at Mt Cashel Orphanage in Newfoundland. I had a number of sessions with one of your counsellors at the time (1993) and felt as though I had built enough courage in myself to dealt with the perpetrator Fr. Placidus Saunder at Westminster Abbey.

At the time I had great belief in the catholic church as they had organised for me to meet with Archbishop Adam Exner, which I did. Ironically he was my bishop of Kamloops whilst I was at SCK. I felt he heard me. I then met with Abbott Maurus Macrae at Westminster Abbey, a meeting the Archbishop Exner's office had arranged. Again I was feeling heard. I met with Fr. Placidus on the same day and he profoundly could not remember the events that had transpired only 11 years earlier. I was devastated. If I was the kind of person to do this I would have reached across the table and knocked his lights out- no acknowledgement, no remorse and worse – no understanding of what I had gone through in those 11 years.

Now I am at the other side of the world and no longer living in Canada. I would have thought that not participating within the church that let me down would make things better; they are not. With the recent charges against Cardinal George Pell and now a civil suit pending against the church from another student that attended SCK prior to me, I know that there are cover-ups. I am also a great example. My greatest disappointment is that you have someone that I confided in; Msgr Gregory Smith on your review panel and I smell another rat! I did not want to be part of the criminal charges against Fr . Placidus as I did not want to have to go through the emotional trauma not just for me but my wife and family. I sincerely hope for those that have truly been damaged by the church with abuse that this is not just another ruse to make those believe that the church cares. I believed in it and it grossly failed me. Don't do this to others as well. Please note that the person (name?)that helped counsel me at the time was the only good thing that has happened to me in all this time.

Since then an archdiocesan group has been working to implement recommendations published in that report. This new report gives an overview on the progress of that group, a few more updates and the publication of an additional three priests involved in abuse settlements that have not been previously published.

If you or someone you know has experienced clergy sexual abuse, we encourage you to report it and take a step towards the healing and care you deserve. Our primary concern is your well-being. We are here to support you in any way we can with your mental, relational and/or spiritual needs.

While an accurate and transparent reporting process of abuse is important, our top priority is that you receive the care and support you deserve. No matter how long ago the abuse may have occurred, we encourage you to come forward. If you want to speak with an independent social worker, please call (604) 363-7338. The people providing this service will compassionately listen to you and outline some possible options for care.

We are aware that many victims/survivors and their families have little or no connection with the Catholic church. But for those who choose to approach us, we are committed to offering you the compassion, respect and path towards the deeper healing that you deserve. You are not alone and people within the Catholic community deeply want to help. We understand how much courage it takes to report your experience and we sincerely hope that each victim will consider coming forward.

Introduction

In late 2019, the Archdiocese of Vancouver published a report on the historical cases of clergy sexual abuse in the archdiocese. While the subject and findings are troubling for many, the response received was positive overall, and much good has come from the steps taken. Subsequent to the Report, 13 previously unknown victims/survivors have come forward and reported their experiences. In most cases, meetings with representatives of the Archdiocese have taken place and support services, including counselling, have been offered.

We understand that some people think that we should speak less about this issue because it may seem that it feeds into an "antifaith" narrative. Moreover, the vast majority of reported abuse cases occurred between the 1960s through the 1980s. Others, including some victims/survivors, think that we are still not doing enough to address the issue and they remind us that recent and future cases may yet come to light.

We believe that greater transparency allows us to reach and care for more victims/survivors while increasing vigilance and safe environments within our parishes. Catholics are called to accept the hard truth of clerical sexual abuse and to live lives of charity and mercy especially reaching out to the most suffering among us. We ask for your

abuse and to live lives of charty and mercy, especially reaching out to the most suffering among us. we ask for your prayers and patience as the Archdiocese does its best to address this painful issue effectively and with compassion. Archbishop J. Michael Miller stated, "We again want to acknowledge the deep suffering of the victims and their loved ones and I apologize to each of them for the trauma caused by the abuse by a priest. They are in my prayers."

Update

The Implementation Working Group ("IWG") was formed to assist in the development and application of solutions proposed in the Case Review Committee's ("CRC") final report, dated Nov. 25, 2019. (The report can be found online at <u>rcav.org/abuse-crisis/abuse-report</u>).

A number of the 31 recommendations were already implemented by that date; many are still in progress. Below is a list of three categories:

- 1. Objectives with significant progress made.
- 2. Objectives that are mostly still outstanding.
- 3. Additional updates.

Progress since the November 2019 Report on Clergy Sexual Abuse

- 1. An independent Intake Office has been established. See Recommendation #1.
- 2. The Review Board has been reconstituted to have a lay chairwoman and a lay majority. See <u>Recommendation #2</u>.
- 3. Updated policies are almost finished and will encourage and protect people bringing allegations forward. See <u>Recommendation #5</u>.
- 4. All known memorials honouring priests known to have abused, have been removed. In several cases, victims/survivors found and reported memorials the Archdiocese had missed. See <u>Recommendation #8</u>.
- 5. All known online/public references and celebrations of priests known to have abused have been removed, but with more than 100 years of newspaper coverage and more than 30 years of online material, we are aware that more may exist. See <u>Recommendation #9</u>.
- 6. An ad hoc seminary committee has been formed and is meeting regularly to recommend improvements to the seminary application and formation process. See <u>Recommendation #19</u>.
- 7. The Archdiocese appointed its first female Chancellor and hired several other women in leadership positions. See <u>Recommendation #26</u>.
- 8. The Canadian Conference of Catholic Bishops (CCCB) established the Standing Committee for Responsible Ministry and the Protection of Minors and Vulnerable Persons to oversee the improvement of Safe Environment policies, work towards a national response to clergy sexual abuse, and establish systems to increase accountability for bishops. See <u>Recommendation #27</u>.
- 9. This CCCB committee has selected a national system for reporting sexual abuse by bishops and has committed to improved information sharing nationally. See <u>Recommendation #28</u>.
- 10. The Archdiocese has contacted all religious orders and communities who have sent clerics to work in Vancouver. The majority have responded and provided the information requested and the remainder will not

be able to send a cleric until the information is received. See Recommendation #29.

11. The Archdiocese has shared all available information with religious orders who have members accused of

clerical sexual abuse in Vancouver. See <u>Recommendation #30</u>.

Objectives Still Outstanding

- 1. Archdiocesan employees are still filling this role while a full victim/survivor support system is being developed. See <u>Recommendation #4</u>.
- 2. The two independent investigators are working through the files of accused clerics and can bring in other support resources as needed. See <u>Recommendation #10</u>.
- 3. The pandemic has delayed parish-based training but remote education and tracking has continued. See <u>Recommendation #14</u>.
- 4. Several priest performance review programs have been analyzed but none have yet been implemented. See

Recommendation #15.

- 5. Priests have been identified for training to become "trauma-informed" resources for any victims/survivors who wish to connect with a priest, but this system is not yet in place. See <u>Recommendation #18</u>.
- 6. A process for supporting admitted abusers yet to be finalized. No priest has volunteered to receive such support. See <u>Recommendation #22</u>.
- 7. No parish-based clergy abuse response events have occurred in 2020 but post-pandemic events are being planned based on the listening session model established in Victoria. See <u>Recommendation #23</u>.
- 8. The first All Survivors Day prayer service was held on November 3rd at Holy Rosary Cathedral. Unfortunately, the event was planned late and had insufficient victim/survivor input. Planning for a more effective 2021 event will begin in the spring. See <u>Recommendation #24</u>.
- 9. A committee to explore ways to address the problem of clericalism has been discussed but has not yet been formed. See <u>Recommendation #25</u>.

Additional Updates

- 1. Policy regarding clerics who father children. The decision was made that any policy would apply only to future cases in which clergy members have fathered children. For past cases, support and obligations have already been established. From 2019 on, the review board will determine the degree to which such priests should be restricted from active ministry and whether they should be encouraged to seek laicization. This has been a difficult decision to reach but was done so after speaking with people directly affected by these situations. See <u>Recommendation #11</u>.
- 2. In the November 2019 Report, recommendation #31 was accidentally misstated. The full recommendation should read, ""As a "bold step" in the interest of the "greater transparency" that you [Archbishop Michael Miller] wrote about in your letter of February 20, 2019, with the goal of "foster(ing) greater trust" and "invit(ing) more input for change" this Committee proposes a group that will meet quarterly whose responsibility it is to review and report on Archdiocese progress in responding to the abuse crisis. These reports will be made public. For the sake of continuity, members of that committee should include (but not be limited to) some representatives of this Clerical Sexual Abuse Case Review Committee." While three members of the IWG were selected from the former Case Review Committee, the IWG is committed to increasing input from independent sources, including other members of the former CRC.

Priest Sexual Abuse Update



Fr. John Edward Kilty was born in 1919 and ordained in 1945. He served at the following parishes in the Archdiocese of Vancouver:

1. Holy Rosary Cathedral, Vancouver: 1945 - 1946

2. Stella Maris Missions: 1946 -1948

3. St. Edmund's, North Vancouver: 1946 - 1948

4. Holy Trinity, North Vancouver: 1948 - 1982

5. Sts. Peter & Paul, Vancouver: 1982 - 1983

Fr. Kilty died in 1983.Twenty years later, in 2003, an allegation of sexual assault of a minor was received from a man and another allegation by a different man was received shortly after. The families involved received counselling and a financial settlement was reached with one party. Another allegation was brought forward in 2013 by a family who believed that their son had been abused, but the person involved decided not to proceed with a claim. In November of 2019, after the publication of the Report on Clergy Abuse, another man came forward with an allegation of sexual abuse when he was a minor in the 1970s. Representatives of the archdiocese met with the man, heard his personal story, and offered him counselling services and other support. In October of 2020 a new allegation was brought forward in a lawsuit alleging sexual abuse of a minor in the 1970s.



Fr. Johannes Holzapfel was born in Germany in 1916, ordained in 1953, and served at the following parishes in the Archdiocese of Vancouver:

1. St. Patrick's, Vancouver: 1955

2. St. Joseph's, Powell River: 1955 - 1956

He left the archdiocese to go to Mexico.

3. St. Margaret's, Ocean Falls: 1958 - 1960

- 4. St. Patrick's, Vancouver: 1960
- 5. Our Lady of Good Hope, Hope: 1960 1963
- 6. St. Joseph's, Squamish: 1963

He took medical leave after refusal of assignment.

- 7. St. John the Apostle, Vancouver: 1965 1966
- 8. St. Margaret's, Ocean Falls: 1966 1967

He requested a leave of absence and release from his priestly vows in Jan 1967. The leave of absence was granted.

He worked at St. Mary's, Vancouver, and at Youville Residence, Vancouver, from 1967.

9. St. Ann's, Abbotsford: 1972 - 1974

He returned to Germany in 1974 and was then incardinated in the Diocese of Aachen. Fr. Holzapfel died in early 1997. Shortly after, the archdiocese received an allegation of physical and sexual abuse of a minor. A financial settlement was reached.



Fr. Armand Frechette was born in 1916 and ordained in 1945. As a Franciscan priest, he served at the following parish in the Archdiocese of Vancouver:

Our Lady of Lourdes, Coquitlam: 1953 - 1970


Fr. Frechette died in 1971. In 1999, a complaint of "improper sexual behaviour" against an unnamed Franciscan priest resulted in a financial settlement. It is now believed that this settlement involved abuse carried out by Fr. Frechette. In early 2020, the archdiocese received an allegation of abuse of a minor by Fr. Frechette. The abuse of the then 9 or 10-year-old boy was believed to have occurred in the mid 1950s. The reporting person has been offered counselling

Conclusion

Some past accusations have been very difficult to assess based on several factors but we will continue to work towards clarity and justice for victims/survivors. Currently, remaining cases fall into the following categories.

- 1. Some clergy files, mostly from the 1960s-80s, have been referred to independent investigators for further review.
- 2. Victims/survivors with settlement agreements must give permission before publication can occur. Some are still being contacted and other discussions are on-going.
- 3. Several other cases from 40-50 years ago are in legal processes so we are unable to comment further at present.

This year, the pandemic negatively affected our schedule for investigations, meetings, and other in-person events that assist in making progress towards fully implementing the recommendations. We hope that 2021 will offer the opportunity to make better progress and engage more fully with victims/survivors and others within the Church and the broader community.

Report on Clergy Sexual Abuse Update

If you or someone you know has experienced clergy sexual abuse, we encourage you to report it and take a step towards the healing and care you deserve. Our primary concern is your well-being. We are here to support you in any way we can with your mental, relational and/or spiritual needs.

While an accurate and transparent reporting process of abuse is important, our top priority is that you receive the care and support you deserve. No matter how long ago the abuse may have occurred, we encourage you to come forward. If you want to speak with an independent social worker, please call (604) 363-7338. The people providing this service will compassionately listen to you and outline some possible options for care.

We are aware that many victims/survivors and their families have little or no connection with the Catholic church. But for those who choose to approach us, we are committed to offering you the compassion, respect and path towards the deeper healing that you deserve. You are not alone and people within the Catholic community deeply want to help. We understand how much courage it takes to report your experience and we sincerely hope that each victim will consider coming forward.

Introduction

In late 2019, the Archdiocese of Vancouver published a report on the historical cases of clergy sexual abuse in the archdiocese. While the subject and findings are troubling for many, the response received was positive overall, and much good has come from the steps taken. Subsequent to the Report, 13 previously unknown victims/survivors have come forward and reported their experiences. In most cases, meetings with representatives of the Archdiocese have taken place and support services, including counselling, have been offered.

We understand that some people think that we should speak less about this issue because it may seem that it feeds into an "antifaith" narrative. Moreover, the vast majority of reported abuse cases occurred between the 1960s through the 1980s. Others, including some victims/survivors, think that we are still not doing enough to address the issue and they remind us that recent and future cases may yet come to light.

We believe that greater transparency allows us to reach and care for more victims/survivors while increasing vigilance and safe environments within our parishes. Catholics are called to accept the hard truth of clerical sexual abuse and to live lives of charity and mercy, especially reaching out to the most suffering among us. We ask for your prayers and patience as the Archdiocese does its best to address this painful issue effectively and with compassion. Archbishop J. Michael Miller stated, "We again want to acknowledge the deep suffering of the victims and their loved ones and I apologize to each of them for the trauma caused by the abuse by a priest. They are in my prayers."

UPDATE

The Implementation Working Group ("IWG") was formed to assist in the development and application of solutions proposed in the Case Review Committee's ("CRC") final report, dated Nov. 25, 2019. (The report can be found online at rcav.org/abuse-crisis/abuse-report).

A number of the 31 recommendations were already implemented by that date; many are still in progress. Below is a list of three categories:

- 1. Objectives with significant progress made.
- 2. Objectives that are mostly still outstanding.
- 3. Additional updates.

- 6. An ad hoc seminary committee has been formed and is meeting regularly to recommend improvements to the seminary application and formation process. See Recommendation #19.
- 7. The Archdiocese appointed its first female Chancellor and hired several other women in leadership positions. See Recommendation #26.
- 8. The Canadian Conference of Catholic Bishops (CCCB) established the Standing Committee for Responsible Ministry and the Protection of Minors and Vulnerable Persons to oversee the improvement of Safe Environment policies, work towards a national response to clergy sexual abuse, and establish systems to increase accountability for bishops. See

Recommendation #27.

- 9. This CCCB committee has selected a national system for reporting sexual abuse by bishops and has committed to improved information sharing nationally. See Recommendation #28.
- 10. The Archdiocese has contacted all religious orders and communities who have sent clerics to work in Vancouver. The majority have responded and provided the information requested and the remainder will not be able to send a cleric until the information is received. See Recommendation #29.
- 11. The Archdiocese has shared all available information with religious orders who have members accused of clerical sexual abuse in Vancouver. See Recommendation #30.

- 5. Priests have been identified for training to become "trauma-informed" resources for any victims/survivors who wish to connect with a priest, but this system is not yet in place. See Recommendation #18.
- 6. A process for supporting admitted abusers yet to be finalized. No priest has volunteered to receive such support. See Recommendation #22.
- 7. No parish-based clergy abuse response events have occurred in 2020 but postpandemic events are being planned based

on the listening session model established in Victoria. See Recommendation #23.

- 8. The first All Survivors Day prayer service was held on November 3rd at Holy Rosary Cathedral. Unfortunately, the event was planned late and had insufficient victim/ survivor input. Planning for a more effective 2021 event will begin in the spring. See Recommendation #24.
- 9. A committee to explore ways to address the problem of clericalism has been discussed but has not yet been formed. See Recommendation #25.

Additional Updates

- 1. Policy regarding clerics who father children. The decision was made that any policy would apply only to future cases in which clergy members have fathered children. For past cases, support and obligations have already been established. From 2019 on, the review board will determine the degree to which such priests should be restricted from active ministry and whether they should be encouraged to seek laicization. This has been a difficult decision to reach but was done so after speaking with people directly affected by these situations. See Recommendation #11.
- 2. In the November 2019 Report, recommendation #31 was accidentally misstated. The full recommendation should read, ""As a "bold step" in the interest of the "greater transparency" that you [Archbishop Michael Miller] wrote about in your letter of February 20, 2019, with the goal of "foster(ing) greater trust" and "invit(ing) more input for change" this Committee proposes a group that will meet quarterly whose responsibility it is to review and report on Archdiocese progress in responding to the abuse crisis. These reports will be made public. For the sake of continuity, members of that committee should include (but not be limited to) some representatives of this Clerical Sexual Abuse Case Review Committee." While three members of the IWG were selected from the former Case Review Committee, the IWG is committed to increasing input from independent sources, including other members of the former CRC.

Priest Sexual Abuse Update



Fr. John Edward Kilty was born in 1919 and ordained in 1945. He served at the following parishes in the Archdiocese of Vancouver:

- Holy Rosary Cathedral, Vancouver: 1945 -1946
- 2. Stella Maris Missions: 1946 1948
- 3. St. Edmund's, North Vancouver: 1946 1948
- 4. Holy Trinity, North Vancouver: 1948 1982
- 5. Sts. Peter & Paul, Vancouver: 1982 1983

Fr. Kilty died in 1983. Twenty years later, in 2003, an allegation of sexual assault of a minor was received from a man and another allegation by a different man was received shortly after. The families involved received counselling and a financial settlement was reached with one party. Another allegation was brought forward in 2013 by a family who believed that their son had been abused, but the person involved decided not to proceed with a claim. In November of 2019, after the publication of the Report on Clergy Abuse, another man came forward with an allegation of sexual abuse when he was a minor in the 1970s. Representatives of the archdiocese met with the man, heard his personal story, and offered him counselling services and other support. In October of 2020 a new allegation was brought forward in a lawsuit alleging sexual abuse of a minor in the 1970s.



Fr. Johannes Holzapfel was born in Germany in 1916, ordained in 1953, and served at the following parishes in the Archdiocese of Vancouver:

- 1. St. Patrick's, Vancouver: 1955
- 2. St. Joseph's, Powell River: 1955 1956

He left the archdiocese to go to Mexico.

- 3. St. Margaret's, Ocean Falls: 1958 1960
- 4. St. Patrick's, Vancouver: 1960
- 5. Our Lady of Good Hope, Hope: 1960 1963
- 6. St. Joseph's, Squamish: 1963

He took medical leave after refusal of assignment.

St. John the Apostle, Vancouver: 1965 - 1966
 St. Margaret's, Ocean Falls: 1966 - 1967

He requested a leave of absence and release from his priestly vows in Jan 1967. The leave of absence was granted.

He worked at St. Mary's, Vancouver, and at Youville Residence, Vancouver, from 1967.

9. St. Ann's, Abbotsford: 1972 - 1974

He returned to Germany in 1974 and was then incardinated in the Diocese of Aachen. Fr. Holzapfel died in early 1997. Shortly after, the archdiocese received an allegation of physical and sexual abuse of a minor. A financial settlement was reached.



Fr. Armand Frechette was born in 1916 and ordained in 1945. As a Franciscan priest, he served at the following parish in the Archdiocese of Vancouver:

Our Lady of Lourdes, Coquitlam: 1953 - 1970

Fr. Frechette died in 1971. In 1999, a complaint of "improper sexual behaviour" against an unnamed Franciscan priest resulted in a financial settlement. It is now believed that this settlement involved abuse carried out by Fr. Frechette. In early 2020, the archdiocese received an allegation of abuse of a minor by Fr. Frechette. The abuse of the then 9 or 10-year-old boy was believed to have occurred in the mid 1950s. The reporting person has been offered counselling and has received a financial settlement to his claim.

Michael Miller, CSB, is committed to publishing regular updates regarding the implementation of the recommendations received from the <u>Case Review Committee</u> (CRC) in late 2019. The <u>Implementation Working Group</u> ("IWG") oversees this work and will publish progress reports each June and November for the foreseeable future.

The process is bearing fruit. This report shares both positive developments as well as ongoing challenges. In addition, we have been sharing our resources and strategies with other dioceses in Canada.

This work is critical to helping people heal who have been deeply affected by clergy abuse. The Church is firmly committed to addressing clerical sexual abuse and underlying contributing factors fully and honestly. Our goal is to put an end to clerical sexual abuse.

Progress Since the December 2020 Update

Objectives Still Outstanding

Corrections and Updates Section

The Archdiocese provided counselling to, and reached financial settlements with, the victim/survivors. In addition, a member of the CRC received an allegation from someone reporting abuse while Holzapfel was in Port Alice BC in the 1950s. The person remembers sharing her experiences with someone at her church in 1986; she reported feeling dismissed and even being told that she was vindictive for raising the issue. This person recently died. While the Archdiocese does not have a record of this interaction, we want to share her story.

In 1989, Br. English was charged with abuse of minors at St. Thomas More Collegiate. During the proceedings, it was proven that his previous abuse at the Mount Cashel orphanage had been known to local government and law enforcement, but all parties reached an agreement requiring Br. English to leave the province. He received "treatment" before the Christian Brothers transferred him to BC, without informing the Archdiocese of his past abuse. He taught here up until the time of his arrest. The Archdiocese of Vancouver did not appoint or employ teachers at schools run by the Christian Brothers. A new class action lawsuit related to sexual abuse at certain Christian Brothers schools was filed in February 2021 and is currently before the courts. A further update on this class action is provided below.



Fr. Frederick Robert Nielsen was born on May 10, 1935, and ordained June 2, 1962, as a priest of the Archdiocese of Edmonton. Following his education at Columbia University, he served in the following role in the Archdiocese of Vancouver:

In late 2013 the Archdiocese received complaints from a total of five individuals alleging sexual abuse in the 1971/72 school year. As a result, Fr. Nielsen entered into a settlement agreement and immediately ceased his ministry.

In 1998, the Archdiocese received an allegation of "sexual misconduct involving an adult man." When confronted with this allegation, Fr. Mendenhall admitted that "it might have occurred." Counselling and a financial settlement were provided, and Fr. Mendenhall agreed to certain restrictions in his ministry. In 2003, a second man came forward with a similar allegation. After an investigation, Fr. Mendenhall admitted to the facts of the case and resigned from Sts. Joachim and Ann. He abruptly ceased prescribed "assessment and treatment", abandoned his ministry and left the country shortly after. He was laicized in 2019 after having been absent from his post for years.

Class Action Lawsuit Regarding Clerical Sexual Abuse

In 2020, the Archdiocese was served with a Notice of a Class Action lawsuit on behalf of any victims of clerical sexual abuse during a time horizon which is yet to be determined. While a Fr. Conaghan was named, the Archdiocese has not received any additional complaints regarding this priest and people participating in this legal action will be able to name other clergy members. We will provide updates as the class is defined and the suit progresses.

Class Action Lawsuit Regarding Abuse at Vancouver College and St. Thomas More Collegiate

In 2021, the Archdiocese was served with a Notice of a Class Action lawsuit on behalf of any victims of sexual abuse by the Christian Brothers who worked at their two local high schools between the years of 1963 to present. Br. Edward English (profile above) was named as an accused and other Brothers may be added. The Archdiocese has never operated these two schools. The action is currently before the courts. We will provide updates as the suit progresses.

Additional Cases

Two additional cases are in settlement discussions and legal processes are ongoing. We will not disclose the alleged offenders at this time out of respect for the victim/survivors' process. We anticipate addressing these cases in the November 2021 report.

How do you recognize clericalism?

In November of 2019, the <u>Report on Clerical Sexual Abuse</u> made 31 recommendations for preventing and investigating sexual abuse in the Archdiocese of Vancouver. In particular, <u>recommendation #25</u> called for "...the immediate establishment of a leadership team comprised of lay, religious and clergy to prayerfully explore the development of an Archdiocese-wide plan" to combat "the inherent evil of clericalism" within both the laity and clergy of the Archdiocese.

This recommendation requires the development of "...a strategy for developing and maintaining a Church which more fully reflects the spirit of Vatican II (*Lumen gentium* and *Apostolicam actuositatem*, for example)" as individuals, communities, and as an institution.

Archbishop J. Michael Miller, CSB, created a committee to study the problem of clericalism. The new committee's task is to study this recommendation and propose practical measures to reduce clericalism in our archdiocese. The committee includes lay, religious, and clergy. This membership includes two members of the <u>Case Review</u> <u>Committee</u> that made the original recommendation.

To ensure that it has clear focus, the committee has come up with a working definition of clericalism:

Clericalism is a misplacement of responsibility with little or no accountability of the ordained ministers and lay faithful in the people God. This leads the faithful and ordained clergy to expect that ordained ministers are better than and should rule over everyone else among the People of God which further leads to abuses of power and hinders the universal call to holiness and the mission of evangelization.

The committee plans to make practical suggestions that will help our local church establish right relationship between the clergy and laity so that we can all better work together to build God's Kingdom. In doing so, we must retain what is positive in the

exercise of the priestly vocation and its relationship with the laity while working against attitudes and practices that have led to, among other things, abuse.

Our entire community, the laity and clergy, need to understand that we are all part of the problem – and therefore are all part of the solution. On the one hand, some pastors try to reserve all decisions on all matters to themselves, and, on the other hand, too often the lay faithful let their pastor make all the decisions. Neither is healthy for the life of the Church. Priests should understand that their desire to serve does not mean *doing everything*, that one of the primary responsibilities of leadership is to find, encourage and develop leaders within the parish community. Likewise, the laity cannot avoid the responsibilities proper to their own vocation as baptized Christians.

We recognize that in life, achieving "balance" is fundamental. There have been times in the Church's history where the relationship between the clergy and the laity has become totally unbalanced. We need to recognize that to a significant degree the Church's problems – abuse and other scandals – are a consequence of that imbalance and that it is "our" problem as a church, not simply a problem for the clergy to solve an attitude which embeds clericalist attitudes even further.

Pope Francis has called for a Church-wide adoption of *solidarity* from top to bottom – papacy to parish, bishop to parishioner, including all clerics in-between. In his August 2018 "Letter to the People of God," Pope Francis defines *solidarity* as the antithesis of *clericalism*: "If, in the past, the response was one of omission, today we want solidarity, in the deepest, most challenging sense, to become our way of forging present and future history....Consequently, the only way we have to respond to this evil [of clericalism] that has darkened so many lives is to experience it as a task regarding all of us as the People of God."

The committee is working to find practical, measurable, and meaningful ways of putting the Pope's words into practice throughout the Archdiocese. Together we will seek to bring balance, solidarity, and joy to the life of our Church remembering that we have all been called to holiness as members baptized into the priesthood of Christ.

- 1. Sunday School Teacher at St. Michael's Parish, Burnaby: 1978
- 2. Teacher at STM in Burnaby and VC in Vancouver: 1976 to 1987

In 1989, Br. English was charged with abuse of minors at St. Thomas More Collegiate. During the proceedings, it was proven that his previous abuse at the Mount Cashel orphanage had been known to local government and law enforcement, but all parties reached an agreement requiring Br. English to leave the province. He received "treatment" before the Christian Brothers transferred him to BC, without informing the Archdiocese of his past abuse. He taught here up until the time of his arrest. The Archdiocese of Vancouver did not appoint or employ teachers at

schools run by the Christian Brothers. A new class action lawsuit related to sexual abuse at certain Christian Brothers schools was filed in February 2021 and is currently before the courts. A further update on this class action is provided below.



Fr. Frederick Robert Nielsen was born on May 10, 1935, and ordained June 2, 1962, as a priest of the Archdiocese of Edmonton. Following his education at Columbia University, he served in the following role in the Archdiocese of Vancouver:

1. Counsellor at local high schools from 1967 to 1972.

In late 2013 the Archdiocese received complaints from a total of five individuals alleging sexual abuse in the 1971/72 school year. As a result, Fr. Nielsen entered into a settlement agreement and immediately ceased his ministry.



Fr. Duncan George Goguillot was born in Edmonton on May 16, 1934, and ordained June 11, 1960. He served at the following parishes in the Archdiocese of Vancouver:

lawsuit detailing the allegations was filed. The reporting person was an 11–13-year-old boy at the time. Due to this case being before the Court, no further comment can be made at this time.

In 1998, the Archdiocese received an allegation of "sexual misconduct involving an adult man." When confronted with this allegation, Fr. Mendenhall admitted that "it might have occurred." Counselling and a financial settlement were provided, and Fr. Mendenhall agreed to certain restrictions in his ministry. In 2003, a second man came forward with a similar allegation. After an investigation, Fr. Mendenhall admitted to the facts of the case and resigned from Sts. Joachim and Ann. He abruptly ceased prescribed "assessment and treatment", abandoned his ministry and left the country shortly after. He was laicized in 2019 after having been absent from his post for years.

Class Action Lawsuit Regarding Clerical Sexual Abuse

In 2020, the Archdiocese was served with a Notice of a Class Action lawsuit on behalf of any victims of clerical sexual abuse during a time horizon which is yet to be determined. While a Fr. Conaghan was named, the Archdiocese has not received any additional complaints regarding this priest and people participating in this legal action will be able to name other clergy members. We will provide updates as the class is defined and the suit progresses.

Class Action Lawsuit Regarding Abuse at Vancouver College and St. Thomas More Collegiate

In 2021, the Archdiocese was served with a Notice of a Class Action lawsuit on behalf of any victims of sexual abuse by the Christian Brothers who worked at their two local high schools between the years of 1963 to present. Br. Edward English (profile above) was named as an accused and other Brothers may be added. The Archdiocese has never operated these two schools. The action is currently before the courts. We will provide updates as the suit progresses.

Additional Cases

Two additional cases are in settlement discussions and legal processes are ongoing. We will not disclose the alleged offenders at this time out of respect for the victim/survivors' process. We anticipate addressing these cases in the

November 2021 report.

Conclusion

We recognize that priests who continued in ministry after the receipt of allegations should not have been allowed to do so. Thanks to the work of the CRC and other groups, we have been able to improve care for victim/survivors and implement better systems to create safe environments for everyone in our communities. We understand that we have much work to do in order to regain trust and make greater progress in our communities.

How do you recognize clericalism?

In November of 2019, the <u>Report on Clerical Sexual Abuse</u> made 31 recommendations for preventing and investigating sexual abuse in the Archdiocese of Vancouver. In particular, <u>recommendation #25</u> called for "...the immediate establishment of a leadership team comprised of lay, religious and clergy to prayerfully explore the development of an Archdiocese-wide plan" to combat "the inherent evil of clericalism" within both the laity and clergy of the Archdiocese.

This recommendation requires the development of "...a strategy for developing and maintaining a Church which more fully reflects the spirit of Vatican II (*Lumen gentium* and *Apostolicam actuositatem*, for example)" as individuals, communities, and as an institution.

Archbishop J. Michael Miller, CSB, created a committee to study the problem of clericalism. The new committee's task is to study this recommendation and propose practical measures to reduce clericalism in our archdiocese. The committee includes lay, religious, and clergy. This membership includes two members of the <u>Case Review Committee</u> that made the original recommendation.

To ensure that it has clear focus, the committee has come up with a working definition of clericalism:

Clericalism is a misplacement of responsibility with little or no accountability of the ordained ministers and lay faithful in the people God. This leads the faithful and ordained clergy to expect that ordained ministers are better than and should rule over everyone else among the People of God which further leads to abuses of power and hinders the universal call to holiness and the mission of evangelization.

The committee plans to make practical suggestions that will help our local church establish right relationship between the clergy and laity so that we can all better work together to build God's Kingdom. In doing so, we must retain what is positive in the exercise of the priestly vocation and its relationship with the laity while working against attitudes and practices that have led to, among other things, abuse.

Our entire community, the laity and clergy, need to understand that we are all part of the problem – and therefore are all part of the solution. On the one hand, some pastors try to reserve all decisions on all matters to themselves, and, on the other hand, too often the lay faithful let their pastor make all the decisions. Neither is healthy for the life of the Church. Priests should understand that their desire to serve does not mean *doing everything*, that one of the primary responsibilities of leadership is to find, encourage and develop leaders within the parish community. Likewise, the laity cannot avoid the responsibilities proper to their own vocation as baptized Christians.

We recognize that in life, achieving "balance" is fundamental. There have been times in the Church's history where the relationship between the clergy and the laity has become totally unbalanced. We need to recognize that to a significant degree the Church's problems – abuse and other scandals – are a consequence of that imbalance and that it is "our" problem as a church, not simply a problem for the clergy to solve - an attitude which embeds clericalist

attitudes even further.

Pope Francis has called for a Church-wide adoption of *solidarity* from top to bottom – papacy to parish, bishop to parishioner, including all clerics in-between. In his August 2018 "Letter to the People of God," Pope Francis defines *solidarity* as the antithesis of *clericalism*: "If, in the past, the response was one of omission, today we want solidarity, in the deepest, most challenging sense, to become our way of forging present and future history....Consequently, the only way we have to respond to this evil [of clericalism] that has darkened so many lives is to experience it as a task regarding all of us as the People of God."

The committee is working to find practical, measurable, and meaningful ways of putting the Pope's words into practice throughout the Archdiocese. Together we will seek to bring balance, solidarity, and joy to the life of our Church remembering that we have all been called to holiness as members baptized into the priesthood of Christ.

Report on Clergy Sexual Abuse Update

Introduction

With the goal of providing better care for victims, improving reporting systems and increasing transparency, Archbishop J. Michael Miller, CSB, is committed to publishing regular updates regarding the implementation of the recommendations received from the Case Review Committee (CRC) in late 2019 (rcav.org/abuse-crisis/abuse-report/2019#crc). The Implementation Working Group ("IWG") (rcav. org/abuse-crisis/abuse-report/2019#iwg) oversees this work and will publish progress reports each June and November for the foreseeable future.

The process is bearing fruit. This report shares both positive developments as well as ongoing challenges. In addition, we have been sharing our resources and strategies with other dioceses in Canada.

This work is critical to helping people heal who have been deeply affected by clergy abuse. The Church is firmly committed to addressing clerical sexual abuse and underlying contributing factors fully and honestly. Our goal is to put an end to clerical sexual abuse.

Progress since the December 2020 Update

- The Office of Victim/Survivor Support began operating on July 20, 2020. Since then, services have been expanded to include the Dioceses of Victoria, Kamloops, and Prince George. See Recommendation #1.



Objectives Still Outstanding

- At this time, archdiocesan staff are filling the role of accompanying those individuals who report abuse, based on the victim/ survivor preferences. Reporters guide the process in terms of the frequency of communication desired, what resources they wish or need to access, and ongoing updates. The continued development and implementation of a comprehensive Victim/Survivor Care plan is ongoing. See Recommendation #4
- The Archdiocese does not yet have access to files of all priests from religious communities who have served here. See Recommendation #6
- A review of archdiocesan files of all clerics will be undertaken by a third party. This will include a review of priests from religious who served in the Archdiocese. Recommendation #10.
- 4. A system for annual performance reviews has not been completed or

implemented. See Recommendation #15.

- (While almost all known abusers are deceased), no known living abusers have accepted the offer of a support and accountability circle. See Recommendation #22.
- Based on the model developed by the Diocese of Victoria, we are preparing for listening circles to commence once parishes are fully re-opened after the pandemic. See Recommendation #23.

Corrections and Updates Section

The IWG wishes to correct the November 2019 and 2020 reports that implied the CRC reviewed all the clerical sexual abuse related files. This was not the case. Some members of the Committee reviewed the files and orally presented summaries covering a selection of the files and the information therein to the Committee members. Other issues involving abusive forms of misconduct were only discussed in general terms.

Holzapfel died in Germany in early 1997. One victim/survivor came forward in the 1990's and another in 2007. Both reports related to his time spent in St. Mary's Parish, Vancouver, in the 1960s and included allegations of physical and sexual abuse of a minor. The Archdiocese provided counselling to, and reached financial settlements with, the victim/survivors. In addition, a member of the CRC received an allegation from someone reporting abuse

while Holzapfel was in Port Alice BC in the 1950s. The person remembers sharing her experiences with someone at her church in 1986; she reported feeling dismissed and even being told that she was vindictive for raising the issue. This person recently died. While the Archdiocese does not have a record of this interaction, we want to share her story.

Introduction

In early 2019, Archbishop Michael Miller formed a Clergy Abuse Case Review Committee to look at historical incidents of clergy sexual abuse in the Archdiocese of Vancouver. The Committee was also asked to review systems and policies so as to find opportunities for improvement in how victims/survivors are cared for and how abuse is reported. A detailed report was submitted to the Archbishop and an Implementation Working Group ("IWG") was established to implement the approved recommendations.

While the majority of the original 31 Recommendations submitted have now been implemented, the Archdiocese continues to take action for victims/survivors. Lay-led reviews of any new priest abuse reports are now standard and victims/survivors can now report their experiences to an independent office staffed with social workers and counsellors. We are also tackling root issues like clericalism and the need for transparency to ensure that all community members understand that priests are not in any way above the people they are called to serve.

This update is provided as a part of the IWG's commitment to publishing two Updates per year. While the Archdiocese is receiving fewer new reports of abuse, extensive work still remains to be done in order to better care for victims/survivors and increase awareness among all Catholics about clerical sexual abuse. Complacency can set in, but as a Church we cannot let that happen. Our goal is to put an end to clerical sexual abuse.

While a priest was named, the Archdiocese has not received any additional complaints regarding this priest and people participating in this legal action will be able to name other clergy members. We will provide updates as the class is defined and the suit progresses.

Class Action Lawsuit Regarding Abuse at Vancouver College and St. Thomas More Collegiate

In 2021, the Archdiocese was served with a Notice of a Class Action lawsuit on behalf of any victims of sexual abuse by Christian Brothers who worked at their two local high schools between the years of 1963 to present. Bro. Edward English was named as an accused and other brothers may be added. The action is currently before the courts, and we will provide updates as the suit progresses.

Additional Cases

Additional cases are in settlement discussions and/ or have legal processes that are ongoing. We will not disclose the alleged offenders at this time out of respect for the victims/survivors' process. We hope to address these cases in the June 2022 report.

Conclusion

We recognize that many situations experienced decades ago would be handled very differently if a report of sexual abuse were received today. Thanks to the work of the Case Review Committee and other groups engaged in this critical issue, the Archdiocese has been able to improve care for victims/survivors and implement better systems to create safer environments for everyone in our communities. As the pandemic winds down, we are also committed to more opportunities for educational sessions, including some with opportunities for victims/ survivors to share their stories.

Helping priests listen to survivors

At the centre of Dr. Deborah Rodríguez's ministry is a thankful appreciation for God's grace, a survivor's empathy, and the belief that both laity and priests need to develop the skills necessary to help them care for survivors of clerical sexual abuse who might come to the Church searching for healing.

Many people struggle to approach the topic of clerical abuse because of the painful feelings that it brings up. Part of the team at Hopeful Hearts Ministry near Seattle, Dr. Rodríguez works with laity and clergy to help them understand trauma so they can get past those feelings. In her ministry she works to give both clergy and laity a framework for approaching survivors of sexual abuse that is grounded in sound trauma science.

Rodríguez, who contributed to the book: Abuse of Trust: Healing from Clerical Sexual Abuse, gave a talk for priests in the Archdiocese of Vancouver in October to help them learn best practices for receiving survivors' stories of trauma.

Because of the stigma around trauma it can take time for priests to be comfortable discussing clerical abuse, she said. Their vocation can make it difficult for them to approach the topic talk about it, especially when confronted with a victim, like she is.

"Once that a priest knows I am a survivor of clerical abuse, they go into protection mode," she told The B.C. Catholic. "There is always an emotional response – [they are] fearful perhaps." Because she is so familiar with priests' responses, she knows she has to "wait and acknowledge" that emotion from them.

Her approach to helping priests engage with and move past their discomfort is rooted in the same principles that guide her work with trauma survivors. She says everyone has experienced some kind of trauma in their past, and when she works with priests she is able to present herself as someone who has experienced pain and suffering, just like them. "Once this sameness becomes the foundation of the conversation there is safety and we can move forward," she said.

When survivors of clerical sexual abuse come to a church looking for healing they often report being retraumatized by the experience. There are a variety of causes, but often it boils down to the fact that priests and other parish workers don't have the skills or experience necessary to deal with a traumatized individual.

"Survivors don't feel safe in a lot of church settings," Rodriguez said. When they disclose their story, "they often are retraumatized because priests and other religious are unfamiliar with how to help a survivor reveal a story."

Rodriguez has advice for those who want to learn to minister to trauma survivors and more fully manifest Christ in their lives. "All you do is receive the story first.

No one has to fix anything, no one has to be a counsellor. You just receive it and sit with it for a while. You sit there with it, then [simply say] 'thank you for sharing that,' then 'what can I do, how can I help?'"

To make the first contact a "safe" experience that leads to healing she recommends using a simple mnemonic device called V.E.E.E.L. Validate, Empathize, Empower, Explain, and Leave the door open.

Some simple phrases and questions illustrate each step of the process: Validate: "I have heard you, thank you for sharing your story with me." Empathize: "I want to understand how you are feeling / I have to be honest, this makes me feel sad/angry/ frustrated." Empower: "I admire your courage. How can I help you?" Explain: "This is what I know/what I can do/ what I cannot do." Leave the door open: "I will be here for you / I will keep you in my prayers."

The goal is to create an environment of safety, which is the most important thing Rodríguez wants people to understand about dealing with people who have suffered trauma. Accepting their stories without judgment or critique goes a long way to helping them feel comfortable, which in turn puts them on the road to healing.

When trauma has damaged your sense of God

The latest addition to the Archdiocese of Vancouver's Review Board on clerical sexual abuse cases brings not just her background as a survivor of clerical abuse, but her professional experience working on mental health and homelessness.

Cathy Lins' two areas of expertise, which include collaboration with U.S. federal agencies, will be of special value to the board, given that survivors of abuse from Canada's residential school system often find themselves homeless in places like Vancouver's Downtown Eastside.

Lins is founder of Gather My Sheep, a Wisconsin-based Catholic ministry helping abuse victims find a path back to the Church. In a 2020 interview with The National Catholic Register, Lins said "research shows that when people are in distress, church is the first place they turn ... Unfortunately, many parishes aren't equipped to support those

dealing with psychological trauma. I've heard many horror stories of the hurtful treatment people have received at their local parish."

As a result, they turn to yoga, nature, "anything but Jesus Christ and his Church."

It's because of those traumatic incidents that Lins felt inspired to help churches become places of healing. Speaking with *The B.C. Catholic*, Lins recounted a prayer she offered after a speaking engagement where she encountered an overwhelming number of such negative stories. "Lord, there is a reason why you wanted me to see this. You wanted me to see the suffering of your people ... How do we make sure that [your] Church actually works as a healing place?"

Helping Catholics and priests become truly welcoming isn't a problem of will or desire. Many churches train missionaries to go out and welcome people into relationship with Christ. But a common theme emerges when they encounter people with mental illness: "They come back and say, 'we don't know what to do.'"

Lins believes the simplest and best way for Christians to get better at ministering to those with mental health problems is to get "mental health first aid training." The intention is not to save people, but to stabilize them, mentally, so they can get the professional help they might need.

The training focuses on a few core ideas that might be familiar to people with CPR training, including doing a harm assessment by asking, "Is this person a danger to themselves or others?"

In mental health, watching your own mental state, or co-regulating, is important because people react to others' emotions. "If [you are] angry and upset the other person will respond in kind," she said. "You need to bring your emotions down, [bring] your voice and volume down."

Beyond mental health, there are spiritual problems to be tackled as well, Lins said. These issues can be especially acute among survivors of clerical abuse. "Because of their trauma, their sense of God has been damaged."

The sacraments can be especially difficult. Lins recounted how it took time for her to be comfortable with the sacrament of reconciliation, sometimes feeling as though she was being locked in a small room with one of her past tormentors.

In a more positive recollection, Lins described working with a priest who would remove his clerical collar so she would feel more comfortable.

When people are taught to understand the symptoms and realities of mental illness, it helps to destigmatize their problems, Lins said, and by understanding what is happening when someone is in emotional distress, there is less getting in the way of loving them.

Canon law revisions on sexual abuse 'a major improvement'

Canon law experts in the Archdiocese of Vancouver are welcoming changes to Church legislation that respond with a more victim-centred approach to sexual abuse of children by members of the Church.

The revisions to Book VI of the Code of Canon Law take effect Dec. 8, the Feast of the Immaculate Conception, and were announced May 31 through Pope Francis' apostolic constitution *Pascite gregem Dei* ("Tend the Flock of God"). The changes were first commissioned by Pope Benedict XVI to improve the effectiveness of the code's penalties for sexual abuse.

The new law says crimes of sexual abuse against minors and vulnerable persons are "offences against human life, dignity, and liberty" rather than breaches of priestly celibacy, as the previous legislation stated.

Canonists from across Canada and around the world agree "the changes to the law are welcome and will help the Church respond effectively" to abuse in the Church, said Msgr. Smith.

"The innovations reflect not only recent experience with abuse cases but also the new roles of the laity in Church leadership and administration."

Dr. Lynda Robitaille, Dean of Theology at St. Mark's College and the new president of the Canon Law Society of America, said establishing that sexual abuse crimes are not only committed by priests and against minors is "an important focus" of the new law.

The revised law provides canonical sanctions for abuse crimes not only with a minor but also "with a person who habitually has an imperfect use of reason or with one to whom the law recognizes equal protection."

The revised law provides penalties not only for clergy who commit sexual abuse but also "a member of an institute of consecrated life or of a society of apostolic life, or any one of the faithful who enjoys a dignity or performs an office or function in the Church."

In a recent presentation to U.S. bishops, Archbishop Charles Scicluna, who also serves as Adjunct Secretary for the Congregation for the Doctrine of the Faith, indicated local diocesan bishops will be responsible for treating allegations of clerical sexual misconduct with a vulnerable adult as a canonical crime and prosecuting them as strictly as sexual abuse of minors.

Offences could include coercive sexual harassment of seminarians by priests or formators as well as sexual contact between a priest and someone employed by them or under their pastoral care. "Such cases of clerical sexual

misconduct with adults have previously been treated as moral failure, but not canonical crimes," Robitaille said.


The Canon Law Society of America expressed gratitude for the revisions, saying the changes were needed.

"This reinvigoration of canon law is a welcome necessity to our member canonists' work on behalf of the Church and will be, as the Holy Father says, an instrument for the good of souls," said Msgr. C. Michael Padazinski, former president of the canon law society.

The revised Book VI was announced on Monday, May 31, through Pope Francis' apostolic constitution *Pascite gregem Dei* ("Tend the Flock of God"). The revisions were first commissioned by Pope Benedict XVI to improve the efficacy of the code's penal sanctions.



In early 2019, Archbishop Michael Miller formed a Clergy Abuse Case Review Committee to look at historical incidents of clergy sexual abuse in the Archdiocese of Vancouver. The Committee was also asked to review systems and policies so as to find opportunities for improvement in how victims/survivors are cared for and how abuse is reported. A detailed report was submitted to the Archbishop and an Implementation Working Group ("IWG") was established to implement the approved recommendations.





Explain: "This is what I know/what I can do/ what I cannot do." Leave the door open: "I will be here for you / I will keep you in my prayers."

The goal is to create an environment of safety, which is the most important thing Rodríguez wants people to understand about dealing with people who have suffered trauma. Accepting their stories without judgment or critique goes a long way to helping them feel comfortable, which in turn puts them on the road to healing. 🗖

When trauma has damaged your sense of God

he latest addition to the Archdiocese of Vancouver's Review Board on clerical sexual abuse cases brings not just her background as a survivor of clerical abuse, but her professional experience working on mental health and homelessness.

Cathy Lins' two areas of expertise, which include collaboration with U.S. federal agencies, will be of special value to the board, given that survivors of abuse from Canada's residential school system often find them-

selves homeless in places like Vancouver's Downtown Eastside.

Sheep, a Wisconsin-based Catholic ministry helping abuse victims find a path back to the Church. In a 2020 interview with The National Catholic Register, Lins said "research shows that when people are in distress, church is the first place they turn ... Unfortunately, many parishes aren't equipped to support those dealing with psychological trauma. I've heard many horror stories of the hurtful treatment people have received at their local parish."

As a result, they turn to yoga, Lins is founder of Gather My nature, "anything but Jesus

Christ and his Church."

It's because of those traumatic incidents that Lins felt inspired to help churches become places of healing. Speaking with The B.C. Catholic, Lins recounted a prayer she offered after a speaking engagement where she encountered an overwhelming number of such negative stories. "Lord, there is a reason why you wanted me to see this. You wanted me to see the suffering of your people ... How do we make sure that [your] Church actually works as a healing place?"

Helping Catholics and priests

become truly welcoming isn't a problem of will or desire. Many churches train missionaries to go out and welcome people into relationship with Christ. But a common theme emerges when they encounter people with mental illness: "They come back and say, 'we don't know what to do.""

Lins believes the simplest and best way for Christians to get better at ministering to those with mental health problems is to get "mental health first aid training." The intention is not to save people, but to stabilize them, Continued on Page 13

Canon law revisions on sexual abuse 'a major improvement'

anon law experts in the Archdiocese of Vancouver are welcoming changes to Church legislation that respond with a more victim-centred approach to sexual abuse of children by members of the Church.

The revisions to Book VI of the Code of Canon Law take effect Dec. 8, the Feast of the Immaculate Conception, and were announced May 31 through Pope Francis' apostolic constitution Pascite gregem Dei ("Tend the Flock of God"). The changes were first commissioned by Pope Benedict XVI to improve the effectiveness of the code's penalties for sexual abuse.

The new law says crimes of sexual abuse against minors and vulnerable persons are "offences against human life, dignity, and liberty" rather than breaches of priestly celibacy, as the previous legislation stated.

The revisions, which also provide for canonical penalties for abuse committed by consecrated religious and lay persons in Church leadership positions, are "a major improvement," said canon lawyer Msgr. Gregory Smith.

Canonists from across Canada and around the world agree "the changes to the law are welcome and will help the Church re-

spond effectively" to abuse in the Church, said Msgr. Smith.

"The innovations reflect not only recent experience with abuse cases but also the new roles of the laity in Church leadership and administration."

Dr. Lynda Robitaille, Dean of Theology at St. Mark's College and the new president of the Canon Law Society of America, said establishing that sexual

the professional help they might need. The training focuses on

a few core ideas that might be familiar to people with CPR training, including doing a harm assessment by asking, "Is this person a danger to themselves or others?"

In mental health, watching your own mental state, or co-regulating, is important because people react to others' emotions. "If [you are] angry and upset the other person will respond in kind," she said. "You need to bring your emotions down, [bring] your voice and volume down."

Beyond mental health, there are spiritual problems to be tackled as well, Lins said. These issues can be especially acute among survivors of clerical abuse. "Because of their trauma, their sense of God has been damaged."

The sacraments can be especially difficult. Lins recounted how it took time for her to be comfortable with the sacrament of reconciliation, sometimes feeling as though she was way of loving them. \Box

being locked in a small room with one of her past tormentors.

In a more positive recollection, Lins described working with a priest who would remove his clerical collar so she would feel more comfortable.

When people are taught to understand the symptoms and realities of mental illness, it helps to destigmatize their problems, Lins said, and by understanding what is happening when someone is in emotional distress, there is less getting in the vides canonical sanctions for abuse crimes not only with a minor but also "with a person who habitually has an imperfect use of reason or with one to whom the law recognizes equal protection."

The revised law provides penalties not only for clergy who commit sexual abuse but also "a member of an institute of consecrated life or of a society of apostolic life, or any one of the faithful who enjoys a dignity or performs an office or function in the Church."

In a recent presentation to U.S. bishops, Archbishop Charles Scicluna, who also serves as Adjunct Secretary for the Congregation for the Doctrine of the Faith, indicated local diocesan bishops will be responsible for treating allegations of clerical sexual misconduct

with a vulnerable adult as a canonical crime and prosecuting them as strictly as sexual abuse of minors.

Offences could include coercive sexual harassment of seminarians by priests or formators as well as sexual contact between a priest and someone employed by them or under their pastoral care. "Such cases of clerical sexual misconduct with adults have previously been treated as moral failure, but not canonical crimes," Robitaille said.

The Canon Law Society of America expressed gratitude for the revisions, saying the changes were needed.

"This reinvigoration of canon law is a welcome necessity to our member canonists' work on behalf of the Church and will be, as the Holy Father says, an instrument for the good of Agency files. \Box

The Abbey is aware, of course, of the current civil proceedings which follow upon Father Placidus' actual and alleged misdeeds in the seminary many years ago. The factual nature of some details in the article is in question. In a criminal trial in December 1997, the charges laid against Father Placidus were dismissed as the judge did not consider the witnesses' testimony against Father Placidus to be convincing.

Our concern is for the victims of these delicts and for their healing. We are also aware of the good of the Church and for all who are scandalized by Father Placidus' actions and for failures on our part to respond in timely and appropriate ways.

Please let me and the other SCK formators know how we can help you deal with this deeply troubling part of our history. I plan to speak to you today to listen and clarify matters.

Introduction

In this semi-annual update, the Implementation Working Group ("IWG") is carrying out the work approved by Archbishop J. Michael Miller, CSB, based on the recommendations received from the Case Review Committee ("CRC") in late 2019 (<u>rcav.org/abuse-crisis/abuse-report/2019#crc</u>). The IWG and the Review Board oversee different aspects of the reporting and tracking of abuse related files and the on-going care of victims who are in contact with Church representatives.

The processes currently in place increase accountability while providing a higher level of transparency and care for people reporting occurrences of abuse. This update shares both positive developments as well as ongoing challenges. This work is critical to increasing awareness among Catholics and to helping all people who have been affected by clergy sexual abuse. The Church is firmly committed to addressing this issue and underlying contributing factors fully and honestly.

Progress Since the December 2021 Update

Recommendation #11: An updated version of the Policy on Sexual Misconduct by Clergy is being finalized and a new summary of the reporting of Clergy Sexual Abuse process is now on-line. (<u>rcav.org/abuse-crisis/report-abuse/process</u>)

See Recommendation #14: Parish screening coordinators, priests and other Church employees continue to receive training and resources to help them be more aware of risks and the elements needed for a safe environment. Additional training for the broader Church community is now being developed.

Recommendation #15: Plans are underway to carry out the first Priest performance reviews later this year.

Recommendation #18: Fr. Bryan Duggan, Psy.D. is creating a team of local clerics and designing a program to help priests become more trauma-informed in order to be a support for victim/survivors seeking priest involvement.

Recommendation #19: The ad hoc Seminary Committee has completed its work and recently submitted its report to the Archbishop.

Recommendation #21: To increase transparency, the Archdiocese will provide periodic updates to Sylvia's Site, a victim/survivor-led website.

Recommendation #24: Each parish is receiving prayers of the faithful, paraliturgy ideas and other resources to support a day of remembering for victim survivors.

Recommendation #25: The Clericalism Working group has contributed significantly to the development of the Priest Performance Review commitment and is now focusing on improving the systems of accountability that can be utilized by Parish Pastoral Councils.

Recommendation #26: Since our December 2021 update, women have been named to the following roles in the Archdiocese: Vice-Chancellor, Controller, Director of Parish Support and HR Manager.

Objectives Still Outstanding

Recommendation #4: Internal employees are still developing a more comprehensive Victim/Survivor Care program based on input from mental health and trauma experts, local court Victim Services groups and law enforcement specialists. Our goal is to publish a program summary in the November 2022 update.

Recommendation #10: Several potential 3rd parties experienced in the auditing of historical records have been identified but no selection has been made. To date, only the files of priests with allegations have been fully reviewed. **Recommendation #22**: The IWG has not been able to find someone to develop this program nor have any previous offenders been willing to participate.

Names for Publication

Fr. Placidus Sander

Fr. Placidus Sander was born in Oregon in 1927, ordained in 1952 and died in 2021.

He served in the following roles within the geographic boundaries of the Archdiocese of Vancouver:

- 1. Theology teacher at Christ the King Seminary, Mission BC: 1954-1997
- 2. Rector of Minor Seminary at Christ the King Seminary, Mission, BC: 1955-1965
- 3. Vice-rector at Christ the King Seminary, Mission, BC: 1973-1988

In May of 1987, the Papal Nuncio received an anonymous letter signed "Former Seminarians," alleging that Fr. Placidus was known to have been involved in homosexual activities with high school seminarians and asking that he be removed from his role as Vice-rector. Fr. Placidus was removed from that role nine months after the first letter was received.

In 1993, accusations were brought forward by three men who reported to law enforcement that Fr. Placidus had sexually abused them during their time as minor students at the Seminary of Christ the King. The Court acquitted Fr. Placidus of these charges in 1997. During the hearings, Fr. Placidus admitted to a single sexual encounter with "an older seminarian" and to kissing one student twice. Upon learning of this admission, the Benedictines removed Fr. Placidus from classroom teaching but he continued to act as a Spiritual Advisor for Major Seminarians, lead the chant program and work in the kitchen. In 2017, Fr. Placidus retired to the Infirmary of the Abbey, where he lived until his death on October 15, 2021.

A civil claim regarding the same accusations from the 1993 criminal case has recently been filed.

The allegations are being published by the Archdiocese at this time because the criminal proceedings have concluded and the plaintiff(s) with civil claims have requested such publication. The Archdiocese was previously advised, including by law enforcement representatives, not to publish information during the course of the legal proceedings.


Conclusion
